Proposed Martin Cadillac service center is on the P.I.C.O. Neighborhood Council Land Use Meeting this

Those who attended recent Neighbors United meetings are aware that Martin Cadillac is proposing to establish a service center at S La Cienega Blvd and adjacent addresses. A Community Plan Implementation Overlay

District (CPIO), which went into effect April 14, 2017, prohibits new automotive use establishments within certain distances of one another, aiming to “encourage new infill development that promotes and enhances existing neighborhood character and is not dominated by excessive automobile orientation.”

The Commercial Corridors CPIO District Subarea seeks to enhance the “main street” shopping experience of the community plan area’s major thoroughfares by providing direction for the rehabilitation and adaptive reuse of existing structures as well as incentives for contextual new infill development consistent with the neighborhood character. The intent of the Supplemental Development Regulations is to revitalize neighborhood commercial areas to better serve nearby residential neighborhoods by incentivizing the establishment of much needed services such as full service grocery stores and sit-down restaurants and by promoting both functional and aesthetic upgrading of the area.

During Neighbors United discussions of Martin Cadillac’s proposal, points of consensus included:

- **Longstanding community concern regarding the concentration of auto-related businesses in area,**
- **Support for the intent of the CPIO, which was implemented to promote/attract community serving business (full service groceries, restaurants, etc.),**
- **Deep respect for the community planning process,** (i.e., a CPIO wouldn’t have been implemented without significant input from relevant communities in the West Adams - Baldwin Hills - Leimert community plan area, which includes thousands of stakeholders within and beyond Faircrest Heights)



- **Code is code, and the CPIO has been in effect 17 months. Any requested deviations should be handled via standard procedure (e.g., a variance request), to allow ample public input.**

While some residents asserted that the CPIO should be upheld (i.e., the proposed auto service center should not be allowed), others suggested that if Martin Cadillac offered some substantive community enhancement projects in order to mitigate negative impacts and attract more community serving businesses to the area, perhaps they might support a variance request. Realizing that any variance or exemption sets precedent, all agreed that arguments for a variance should be unique and strong, and proposed mitigations substantial, so the CPIO is not rendered moot.

To solicit additional feedback, the **P.I.C.O. Neighborhood Council Land Use Committee** has placed the proposed service center on their meeting agenda **this Thursday, September 28, 7:00pm** at Claude Pepper Center (1762 S La Cienega Blvd). The meeting agenda is posted on the P.I.C.O. Neighborhood Council website (www.piconc.com). Click on 'For the Record,' then Agendas, and find the file dated 09-22 Land Use Agenda.

We hope you will attend the P.I.C.O. Neighborhood Council Land Use Committee meeting this Thursday, and also our Neighbors United meeting next Monday, for a brief status update.

About Edible Landscapes By Tommy Teeple Invasive mosquitoes are spreading across Los Angeles County. Have you been bitten?

Have you experienced an unusual number of mosquito bites this summer? Have they landed mostly below the knee and especially around your ankles? And did the six-legged perpetrator fly off unnoticed, like a mosquito ninja, after feasting on your blood?

If the answer to all these questions is yes, then your neighborhood is probably infested with an invasive mosquito that is moving rapidly across Southern California, driving residents and vector control specialists crazy. It's called Aedes, and it's a real problem.

So far, no Aedes mosquito in Southern California is known to have transmitted a disease to people. But vector control has a game plan in case it does happen. The good news is that local communities have the power to stop Aedes mosquitoes from breeding, at least in their immediate area. These mosquitoes rarely fly more than 200 yards in their lifetime. That means if you and your neighbors remain vigilant about emptying even tiny sources of standing water on your properties, you can keep them under control. 


