Message from LAPD Wilshire Auto Detectives - Officer Robert Davenport

An Excerpt from a Los Angeles Times Article about Our Storm Drains – Submitted By Dana Pehrson

"...So far this rainy season, sanitation crews have cleaned all 40,000 of the city's catch basins and removed debris from the screens that frequently cover the openings. Still, those catch basins could be blocked again the next time a torrential rain sopping wet seat cushions, construction debris and other items into the gutters.

In recent weeks, Hagekhalil has been promoting the sanitation bureau's 24-hour hotline, (800) 773-2489, as a way for the public to report illegal dumping and jammed-up catch basins. Because of El Niño, the hotline's hours were expanded, he said. "We are looking at areas that are susceptible to flooding, and we are dependent on people calling us and letting us know," he said...." So if you see blocked drain screens, call the hotline or take a moment to remove the debris.

On a side note, during the last El Nino, the Faircrest Heights community experienced considerable flooding—we had "river-front" property. Some neighbors had water seeping into their homes, flooding floor furnaces and crawl spaces under homes, and in a few cases, flooding cars. Residents were required to have flood insurance. However, during the early 2000s the Holly Hills Drain was installed under Crescent Heights Boulevard, from our community and heading north through Beverly Hills and West Hollywood. The flood insurance requirement was released. We should still take precautions to protect our property from potential flooding.

SMALL LOT SUBDIVISION: Public Hearing re: Proposed Amendments to the SLS Ordinance

Many of you are familiar with one of the development trends in our area: SMALL LOT SUBDIVISION. This generally refers to the conversion of properties into subdivisions of a new housing typology that looks and functions like row townhomes, but each unit is built independently on individual "small lots." (The original lots may have had single family homes, but are located in multi-family-zones, generally R2 or R3. To see some examples, see the 1400 block of Hi Point Street.)

The city's Small Lot Ordinance was adopted in 2005. Responding to feedback from the public (primarily related to SLS' impact on neighborhood scale and character), the city will hold public hearings on proposed amendments to the SLS Ordinance, which would require greater front and rear yard setbacks, create a division of land process for "adaptive reuse" small lot projects, and add an incidental administrative clearance process and establish design standards for SLS projects.
